End User License Agreement

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE INSTALLING THE SOFTWARE. THIS AGREEMENT LICENSES THE ENCLOSED SOFTWARE TO YOU AND CONTAINS WARRANTY AND LIABILITY DISCLAIMERS. BY INSTALLING OR USING THE SOFTWARE, YOU ARE AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NEITHER INSTALL NOR USE THE SOFTWARE.

1. Definitions.

- (a) The term "Licenser" means "Dipl.-Ing. Martin Haller, Software-Engineering & EDV-Beratung" and its suppliers.
- (b) The term "**Software**" means the enclosed Licenser's software product and the related documentation and all related updates.
- (c) The term "**registration code**" in this document means the data technical representation of a valid license according to point 5 of this agreement, whatever shape it has (activation code, license number, license file or others).

2. Copyright.

The Software is NOT in the public domain. It is copyrighted by the Licenser. This Software and accompanying documentation are protected by Austrian copyright law and also by international treaty provisions. Structure, organization and source code of the Software are valuable business secrets and confidential information of the Licenser.

3. Distribution.

The **unregistered Software** may be freely distributed, provided that:

- (a) Such distribution includes only the original archive supplied by the Licenser. You may not alter, delete or add any files in the distribution archive.
- (b) Such distribution contains the same copyright and other proprietary notices pertaining to this Software that appear in the Software.
- (c) The distribution does neither include a registration code nor methods, programs or instructions to get or create a registration code or in any other way upgrade the Software from its unregistered status unlawfully.
- (d) No money is charged to the person receiving the Software, beyond reasonable cost of packaging and other overhead.

4. Evaluation License.

You are granted to install the **unregistered Software** on any number of computers and to evaluate it for free as long as you want. All evaluation users are subject to the terms of this agreement. You may not use the Software with any crack program or other means of unlawful upgrading of the unregistered status.

5. License.

This agreement allows you to:

(a) with a single user license:

Install and use the Software on a single client computer at a time and by a single user at a time, subject to the general terms and restrictions listed below and the disclaimer relating to warranties, support and damages.

(b) with a multi user license:

Install and use the Software within a company/organization at a time only on up to the number of client computers as defined by the multi user license, subject to the general terms and restrictions listed below and the disclaimer relating to warranties, support and damages.

(c) Backup:

Make one copy of the Software in machine-readable form solely for backup purposes. You must reproduce on any such copy all copyright notices and any other proprietary legends on the original copy of the Software.

6. Restrictions.

This agreement gives you the right to use this Software but all rights not specifically mentioned in this agreement, including ownership rights, intellectual property rights, trademarks and copyright, are reserved by the Licenser. You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of the Software. You may not transfer, give over, rent, resell or commercialize the Software.

This agreement contains the complete agreement between you and the Licenser with respect to the subject matter hereof, and supersedes all prior or contemporaneous agreement, understanding, presentation, discussion, promise or advertising, whether oral or written.
